



## TeachNet Site Policy Agreement

This Site Policy Agreement (the "Agreement") governs your use of TeachNet's services and resources (the "Services") relating to the Summer Courses offered on the TeachNet.ie website (the "Website"). By accessing or using the Services, you agree to be bound by the terms and conditions contained in this Agreement. If you do not agree to these terms and conditions, you may not access or use the Summer Courses.

### General Terms

- 1.1. TeachNet reserves the right to modify or update this Agreement at any time, without prior notice. Your continued participation on the Summer Course constitutes your acceptance of the revised Agreement.
- 1.2. TeachNet reserves the right to suspend or terminate your access to Summer Courses if you violate this Agreement or any applicable laws, or if your conduct is harmful to the interests of TeachNet or its users.

### User Conduct

- 2.1. You are solely responsible for your conduct while participating on the Summer Course, including but not limited to the content you submit, post, or share through the course platform.
- 2.2. You agree not to engage in any conduct that is unlawful, harassing, discriminatory, defamatory, or invasive of another's privacy, or that otherwise violates the rights of any third party.
- 2.3. You will register using your name as registered with the Teaching Council and agree that impersonation is a breach of the terms of service.

### Data Management and Protection

- 3.1. TeachNet collects, processes, and stores personal data provided by you during registration, enrolment, and participation in the Summer Courses in accordance with the TeachNet Privacy Policy, which is incorporated into this Agreement by reference. By enrolling in the Summer Course, you agree to the collection, processing, and storage of your personal data as described in the TeachNet Privacy Policy.
- 3.2. TeachNet is committed to protecting the privacy and security of the personal information we collect, process, and store from our users. This GDPR Compliance Statement outlines our approach to handling personal data in accordance with the General Data Protection Regulation (GDPR) (EU) 2016/679. We respect your right to privacy and are committed to complying with our data protection obligations.
- 3.3. TeachNet will take appropriate technical and organisational measures to ensure the protection of your personal data against unauthorized access, disclosure, alteration, or

destruction. However, TeachNet cannot guarantee the absolute security of your personal data and disclaims any liability for unauthorized access or loss of your personal data to the fullest extent permitted by law.

3.4. You have the right to access, correct, and delete your personal data held by TeachNet, as well as the right to object to the processing of your personal data for marketing purposes. If the parties fail to reach an agreement within 30 days from the date the dispute was notified by one party to the other, either party may submit the dispute to the competent courts in Ireland.
